### **CIRCULAR S18 OF 2021**

#### **CONFIRMATION OF THE TASK WEIGHTINGS FOR DRAMATIC ARTS, GRADES 10 - 12**

1. This Circular should be read in conjunction with the Abridged Chapter 4 of the Dramatic Arts Programme of Assessment (POA) for Grades 10 - 12.
2. The purpose of this circular is to confirm the number of School Based Assessment (SBA) Tasks and weightings for Dramatic Arts Grades 10-12, aligned to the 2021 Annual Teaching Plan and the Abridged Chapter 4 of Dramatic Arts Grade 10 - 12.
3. Circular S17 of 2021 confirms the revised weightings of the School Based Assessment (SBA) and end of year examination to be 60% SBA and 40% final end of year assessment.

The number of tasks and weightings for the Grade 10 - 12 Dramatic Arts SBA tasks in 2021 are as follows:
